As a reminder to you, Capitation Fees will be based on membership of your Lodge, as per the Grand Lodge Membership database, as at midnight 30<sup>th</sup> June 2017. It is therefore imperative that all membership data is both up to date and accurate. Any Lodge Monthly Returns (LMRs) that have not been lodged should be done as soon as possible, and monthly data, henceforth, provided to this office on a regular monthly basis.

Also, for your information, the discount for early payment of Grand Lodge Dues for 2017/2018 will be \$5.50 per member (unchanged).

To qualify for the discount, payment must be received in Grand Lodge by the 31 August 2017.

Payment of the full 2017/2018 Grand Lodge Dues (single payment) without discount is due by 31 October 2017.
